2. Pauma Valley Country Club Conservation Easement Annual Report.

Background: The 2021 Annual Report will be presented.

Recommendation: That, if they so choose the Board accept the 2021 Annual Report.

3. Acceptance of the Quarterly Arroyo Toad Conservation Easement Report.

4. Possible Termination of Memorandum of Understanding between Mission RCD and USLRRCD.

Background: Yuima MWD received a request on December 28, 2021 from Mission RCD to obtain a 2-year water usage report on an irrigation evaluation that was performed within the district. The current MOU with Mission RCD is for the removal of arundo only, not the performance of irrigation evaluation services. Mission RCD continues to violate the government code despite being aware of its existence.

Recommendation: That, if they so choose to the Board terminate the MOU with Mission RCD.

5. Approval of the Third Amendment to the Memorandum of Understanding for Developing a Groundwater Sustainability Plan for the San Luis Rey Valley Groundwater Basin.

Background: An amendment to the MOU is necessary to add the Pauma Municipal Water District and the San Luis Rey Municipal Water District to the Groundwater Sustainability Agency. The addition of these agencies will allow full coverage of the groundwater basin, closing any white spaces created upon the County of San Diego's withdraw from the GSA.

Recommendation: Approve and authorize the President to sign the Third Amendment to the Memorandum of Understanding for the Development of a Groundwater Sustainability Plan for the San Luis Rey Groundwater Basin subject to recommended revisions made by the General Counsel.

6. Public Hearing to Receive Comments and Consider Adoption of the Groundwater Sustainability Plan.

6-A. Proposed Resolution Recommending Approval of the Groundwater Sustainability Plan for the Pauma Valley Subbasin of the San Luis Rey Groundwater Basin.

Background: The Groundwater Sustainability Plan for the Pauma Valley Subbasin of the San Luis Rey Valley Groundwater Basin has been completed. The Board is requested to adopt the GSP, including any subsequent revisions and direct the District Representatives to formally recommend approval and submission to the state by Yuima at the GSA Executive Team will meet expected to take place on January 21, 2022

Recommendation: That, if they so choose, the Board adopt the resolution as presented.

7. Proposed Resolution to Approve a Memorandum of Understanding Regarding Technical Assistance on Pollinator Habitat to the Agriculture Community and General Public.

Background: Resource Conservation Districts, under Division 9 of the California Public Resources Code, Section 9408, are allowed and encouraged to cooperate and enter into agreements with fellow Resource Conservation Districts in order to accomplish the purpose of Districts to conserve natural resources and provide conservation services. RCDGSDC is providing technical assistance on pollinator habitat to the agriculture community and general public.

Recommendation: That, should the Board approve the Memorandum of Understanding presented, the Board adopt the Resolution.

8. CDFA Water Efficiency Technical Assistance Program (WETA).

Background: RCD of Greater San Diego is going to apply to provide irrigation technical assistance to farmers and ranchers within the districts boundaries.

Recommendation: That, if they so choose, the Board approve the collaboration with RCD of Greater San Diego on the Water Efficiency Technical Assistance Program.

9. Amending Memorandum of Understanding with Resource Conservation District of Greater San Diego.

Background: RCD of Greater San Diego is requesting to update or amend the current MOU that includes addressing the Gold Spotted Oak Borer (GSOB) located at Palomar Mountain.

Recommendation: That, the Board authorize the President to execute the amendment to the MOU that includes the GSOB and the 2022 CALFIRE Fire Prevention Grant.
