1. First Reading of the Ordinance to Establish Rules and Regulations on Setting Regular, Adjourned, Special Meeting and How its Records Shall be Kept and Rescinding Ordinance #5-2021.

Background: The meetings of the Board of Directors shall be held within the boundary of the territory over which said District exercises jurisdiction. Regular Meetings of the Board of Directors shall be held, with 72 hour Public notice, on the 2nd Thursday of each month at 34928 Valley Center Road, Pauma Valley CA at 1:00 p.m. This is the first reading of the ordinance. The second reading of the ordinance will be held at the Special Meeting on April 7, 2022.

2. Revising the Definition of Waters of the United States by the Environmental Protection Agency.

Background: On November 18, 2021, the U.S. Environmental Protection Agency and the Department of the Army ("the agencies)" announced the signing of a proposed rule to revise the definition of "waters of the United States." This proposal marks a key milestone in the regulatory process announced in June, 2021. On December 7, 2021, the proposed rule was published in the *Federal Register*. The agencies propose to put back into place the pre-2015 definition of "waters of the United States," updated to reflect consideration of Supreme Court decision. This familiar approach would support a stable implementation of "waters of the United States" while the agencies continue to consult with states, tribes, local governments, and broad array of stakeholders in both the current implementation and future regulatory actions.

Recommendation: Authorize the Board President to mail a letter to the EPA in regards to the proposed changes to the Waters of the US rule.
