III. ACTION DISCUSSION

1. Proposed Resolution Adopting the Operation Budget for Fiscal Year 2024/2025.

Lyall

1A. Informational Purposes Only: Copy of Insurance premium for new fiscal year. Increase in premium.

Background: Each year the District must adopt an operating budget to demonstrate their ability to perform the required duties of the district in a financially responsible manner.

2. <u>Approval of Agreement for Recordkeeping and Secretarial Services with Yuima</u> Municipal Water District for Fiscal Year 2024-25.

Background: The Board contracted with Yuima MWD to perform Record Keeping and Secretarial Services for July 2023 through June 2024. The included agreement is for the 2024/25 fiscal year for a monthly amount of \$713.69. This is an increase of \$122.58 from the 2023/24 contract. Yuima's Board of Directors approved the contract at their June 24, 2024 board meeting.

Recommendation: That the Board review and approve the contract if they so desire.

Proposed Resolution Establishing the Appropriation Limit for Fiscal Year 2024/25
Pursuant to Article XIIIB of California Constitution.

Background: Annually the District is required to calculate the annual appropriation limit pursuant to Article XIIIB of the State Constitution. The appropriation limit calculation determines the maximum amount of property taxes can be collected for the District. The 2024-25 Appropriation Limit is \$40,982. The District's expected tax revenue apportionment for the 2024-fiscal year is estimated to be \$10,500. The public notice requirement under Government Code Section §7919 have been met as the Notice was Posted on June 25, 2024.

Recommendation: That, should the Board agree, they adopt the Resolution as proposed.
